

## ARTICLES OF ORGANIZATION FOR SPOONBILL HOMES, LLC, A FLORIDA LIMITED LIABILITY COMPANY

#### ARTICLE I. NAME

The name of the Limited Liability Company is "Spoonbill Homes, LLC" (the "Company").

#### ARTICLE II.

The mailing address and street address of the principal office of the Company is 28 Magnolia Avenue, Yankeetown, FL 34498.

#### ARTICLE III. DURATION

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 605.0101 through 605.1108 of the *Florida Revised Statutes Annotated* (the "Act") or the Company's Operating Agreement among the members (the "Operating Agreement").

#### ARTICLE IV. MANAGEMENT

The Limited Liability Company is to be managed by a manager. The initial manager shall be Shelbea R. Sadusky.

#### ARTICLE V. PURPOSE

The purpose for which the Company is being organized is to acquire, and thereafter own, manage, lease, and ultimately resell, residential real estate including single family homes, and to transact any other lawful business approved by the members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.

#### ARTICLE VI. MEMBERS' RIGHTS TO CONTINUE BUSINESS

The right of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company shall be upon the consent of all of the remaining members in accordance with the terms and conditions of
