ARTICLES OF ORGANIZATION

OF

ARTICLE I NAME; APPLICABLE LAW

The name of the limited liability company formed pursuant to the filing of these Articles_of Organization (the "Articles") is "19 N PRIMROSE DR, LLC" (the "Company"). ARTICLE VI RESTRICTIONS ON TRANSPER; ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS

These Articles may not be amended except as provided in the Operating Agreement.
