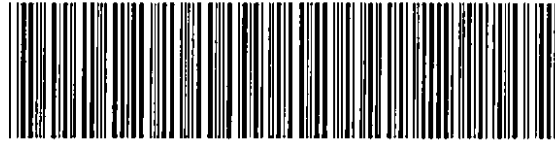

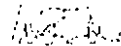

The name of the limited liability company is: Hangar X Holdings, LLC.

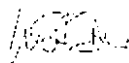
ARTICLE II. ADDRESS

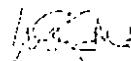
