This limited liability company shall have a perpetual existence, unless dissolved according to law, effective as of the 14th day of November, 2019.

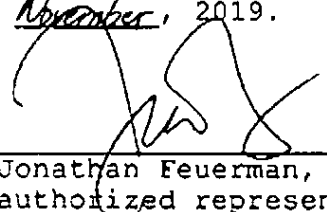
