**ARTICLES OF ORGANIZATION
OF

The undersigned, Kirby H. Williams, a natural person competent to contract and an authorized representative of 60 Clayton Lane, LLC, hereby presents these Articles of Organization as the Articles of Organization of 60 Clayton Lane, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 60 Clayton Lane, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 60 Clayton Lane, Suite B, Santa Rosa Beach, Florida 32459. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS




