**THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF URBAN MEDICINE WOMAN, LLC**, a Florida limited liability company (the "Company"), are executed by the undersigned Authorized Representative of the Company for the purposes set forth herein:
