ARTICLES OF ORGANIZATION OF PIRATES HAUNT, LLC (A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Act").

1. <u>NAME</u>. The name of this limited liability company (the "Company") is **PIRATES** HAUNT, ILC.

2. <u>EFFECTIVE DATE AND DURATION</u>. The existence of the Company shall commence on November 25, 2019. The period of duration of the Company shall be perpetual.
