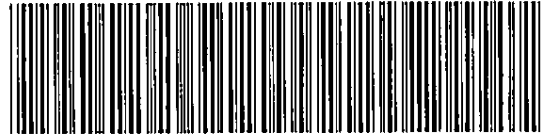

The name of the limited liability company is **SEEING SOUNDS RECORDS LLC** (the "Company").


ARTICLE II - ADDRESS
