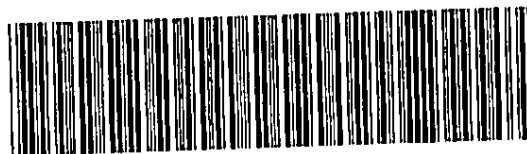

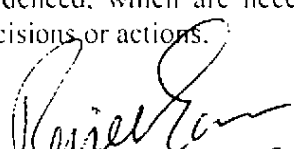

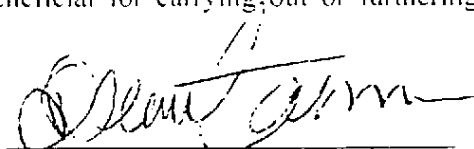
**ARTICLE III - Organization and Purpose**

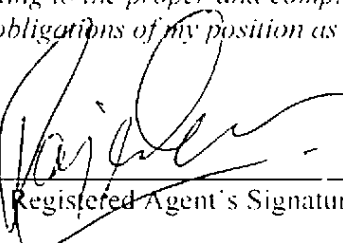

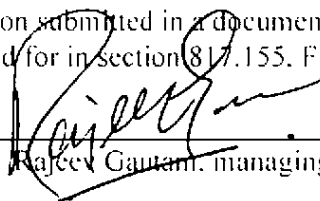
