ARTICLES OF ORGANIZATION

ARTICLE I -- NAME

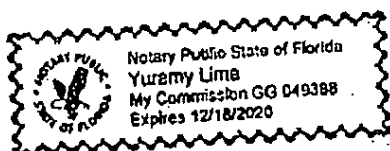




