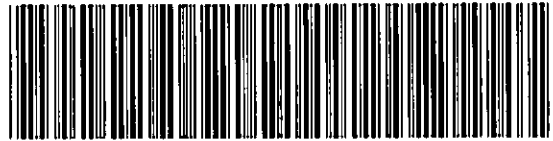

MANAGEMENT**




