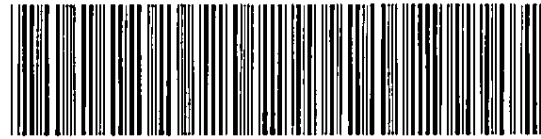

Management






