

ARTICLES OF ORGANIZATION OF 285KEY COLONY, LLC

- 1. Name. The name of this limited liability company is 285KEY COLONY, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
 - 2. <u>Duration</u>. The Company's existence shall be perpetual.

- 7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
