
WHEREAS, RL Tequesta, LLC was organized on December 5, 2019 and assigned Document #119000286303; and

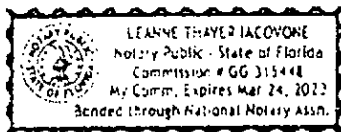
