ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Revised Act, Chapter 605, Florida Statutes hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be 466A CLEVELAND, LLC ("Company").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the LLC is 719 Oaks Shores Road, Leesburg, Florida 34748.

ARTICLE III – DURATION AND PURPOSE

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization.

The purpose of the Company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV – REGISTERED AGENT AND OFFICE

ARTICLE V – ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all members of the Company and on such terms and conditions as shall be determined by all members.

ARTICLE VI – MANAGEMENT

The Company shall be manager – managed by a manager in accordance with the Operating Agreement, appointed by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The initial Manager is Khai S. Chang.

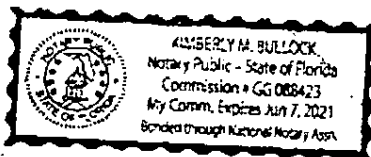
