**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is NSWS Rep, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 10741 Crossroads Commerce Boulevard, Tampa, Florida 33610.


