MANAGEMENT OF THE COMPANY


The management of the Company shall be vested in the managers of the Company, as appointed by the members.

OPERATING AGREEMENT


The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.


