#### ARTICLES OF ORGANIZATION OF **BAYLEN STREET INVESTORS, LLC**

Simmons, a natural person competent to contract and an authorized representative of Baylen Street Investors, LLC, hereby presents these Articles of Organization as the Articles of Organization of Baylen Street Investors, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

#### ARTICLE I - NAME
