**ARTICLES OF ORGANIZATION

**ARTICLE I  
NAME**

The name of the Company shall be: **TAMPAGIRL INVESTMENTS, LLC.**

**ARTICLE II  
ADDRESS AND PLACE OF BUSINESS**

The mailing and street address for the Company's principal office is 2919 SWANN AVENUE, SUITE 401, TAMPA, FLORIDA 33609.

**ARTICLE III  
PERIOD OF DURATION**

The effective date for the filing of these Articles of Organization shall be DECEMBER 6, 2019.

Thereafter the Company shall have perpetual duration.

**ARTICLE IV  
GENERAL POWERS**

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under Florida law.

**ARTICLE V  
OPERATING AGREEMENT**

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be amended or repealed only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida. If no operating agreement is adopted, the regulation, management, and other affairs of the Company shall be governed by Florida Statutes Chapter 605.

**ARTICLE VI  
MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of the members and, except as otherwise provided in the Operating Agreement, the business and affairs of the Company shall be managed by or under the direction of one or more Managers (or Authorized Members). **SUSAN J. STEEN**, 2919 Swann Avenue, Suite 401, Tampa, Florida 33609, shall be the initial Manager.

**ARTICLE VII  
RIGHT TO CONTINUE BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not cease, and the Company shall not be dissolved except by the

ACKNOWLEDGMENT**

The members of the Company, through their undersigned authorized representative, do hereby certify that the foregoing constitutes the TAMPAGIRL INVESTMENTS, LLC Articles of Organization, which may be amended from time to time by the consent of the members holding a majority of the voting interests of the Company, or otherwise in the manner now or hereafter prescribed in the Operating Agreement, consistent with the laws of the State of Florida.


