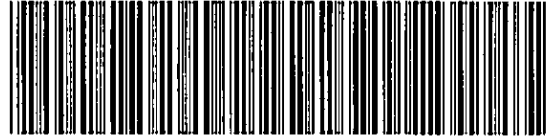

**ARTICLE I
NAME AND MAILING ADDRESS & STREET ADDRESS OF PRINCIPAL OFFICE**






