**ARTICLES OF ORGANIZATION
OF

The undersigned, Mark Hotze, a natural person competent to contract and an authorized representative of 30A Light Tackle, LLC, hereby presents these Articles of Organization as the Articles of Organization of 30A Light Tackle, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is 30A Light Tackle, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

The street and mailing address of the Company’s initial principal office is 181 Pine Street, Santa Rosa Beach, Florida 32459.

ARTICLE III – PURPOSE AND POWERS
