**ARTICLES OF ORGANIZATION
OF

The undersigned hereby submits these Articles of Organization (these "*Articles*") for purposes of forming Guest House Ocala Outpatient Recovery, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*. These Articles shall be effective upon acceptance of filing with the Florida Secretary of State.

ARTICLE I - Name

The name of the company formed pursuant to these Articles is Guest House Ocala Outpatient Recovery, LLC (the "*Company*").

ARTICLE II - Address




