- THIRD:** ARTICLE IV of the Company's Articles of Organization is deleted in its entirety and replaced with the following new ARTICLE IV

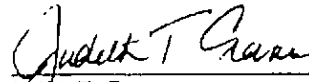
"ARTICLE IV – Management and Officers
