The Company shall be managed by one or more managers as provided in the Company's Operating Agreement, and the initial managers of the Company shall be PATRICK J. HEWITT and

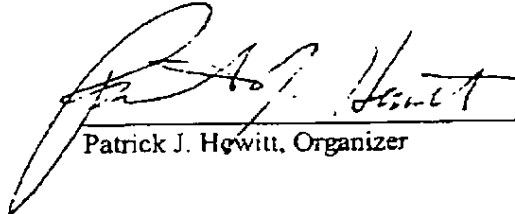

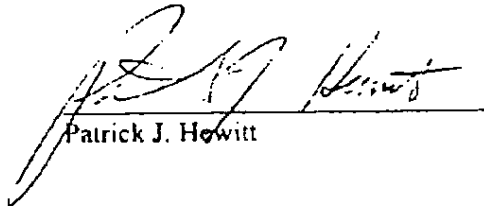
AMY E. COOK-HEWITT. Either manager acting alone shall have full power and authority to bind the Company, and their joint signatures shall not be required for any purpose
