Section 1.01 Introduction and Preliminary Statements

The undersigned Organizer desires to amend Larry D. Smith. PLLC, a limited liability company under the Laws of the State of Florida by delivering these Amended and Restated Articles of Organization to the Secretary of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the *Act*).
