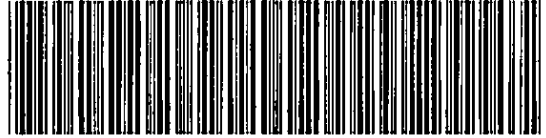

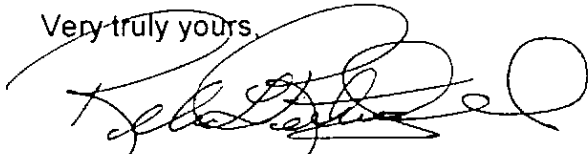

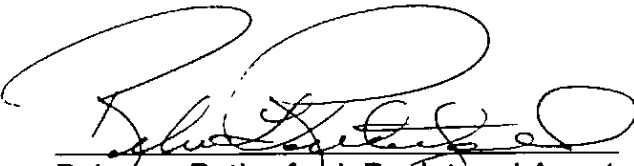

The company may not issue any additional membership interest and no member may transfer, assign, or pledge any membership interest without the prior, written consent of Sonic Franchising, LLC.

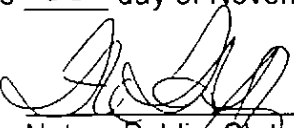

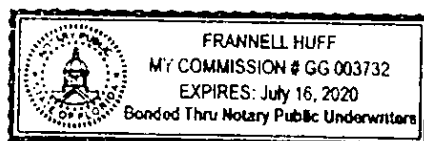
