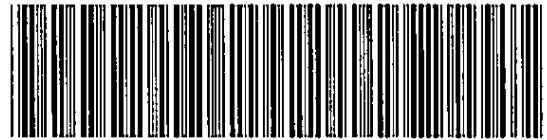

This amendment is submitted to amend the name of the limited liability company. The new name is INDUSTRIAL STEEL CONSTRUCTION LLC.


