**ARTICLES OF ORGANIZATION  
OF  
TAMMY JO RHODES, P.L.L.C.**

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a Professional Limited Liability Company under the laws of the State of Florida.

**ARTICLE I  
NAME**

The name of the Professional Limited Liability Company shall be **TAMMY JO RHODES, P.L.L.C.**

**ARTICLE II  
ADDRESS AND PLACE OF BUSINESS**

The mailing address and principal place of business for the Professional Limited Liability Company is: 1501 60<sup>th</sup> Street S., Gulfport, Florida 33707.

**ARTICLE III  
PERIOD OF DURATION AND EFFECTIVE DATE**

The effective date for the Professional Limited Liability Company shall be January 1, 2020, and shall continue into perpetuity, or until dissolved in a manner provided by law or by regulations adopted by the Members of the limited liability company.

**ARTICLE IV  
PURPOSES**

The purpose of this Professional Limited Liability Company shall be to lawfully engage in the ordinary business of a licensed real estate agent, as such business activities may be determined by the Member from time to time. - (c) list on the MLS real property owned by Member or in which Member otherwise has an interest, and manage such listings; and

(d) engage in all activities that are necessary, incidental, related or convenient to the foregoing (collectively "Business").

The purpose of the Company shall be limited to only those purposes specified in this Article IV. Without the consent of Member, the Company shall not engage in any activity or business other than the Business described herein above.

**ARTICLE V  
REGISTERED OFFICE AND REGISTERED AGENT**

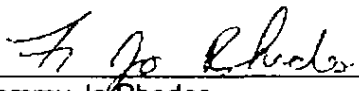
