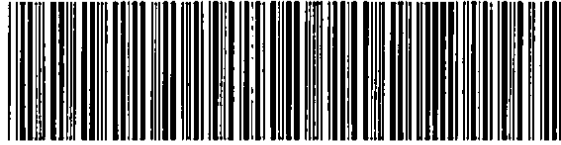

ARTICLE 1 - NAME


The name of this company shall be: **PCP 2006, LLC**
