DURATION**

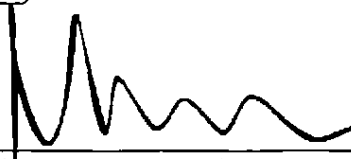

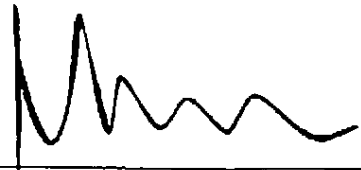
