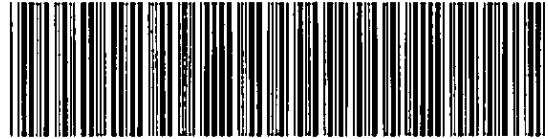



ARTICLES OF ORGANIZATION
OF
CORNERSTONE REALTY AND TRUST, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **CORNERSTONE REALTY AND TRUST, LLC** (“company”).

ARTICLE II – ADDRESS


ARTICLE VI – ADMISSION OF NEW MEMBERS



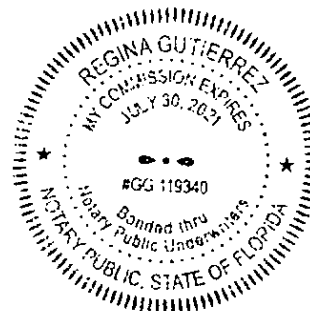
