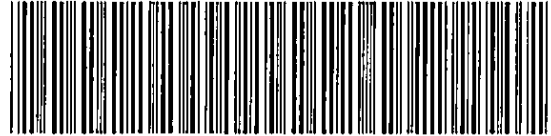

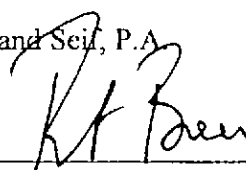

ARTICLES OF ORGANIZATION OF A
FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

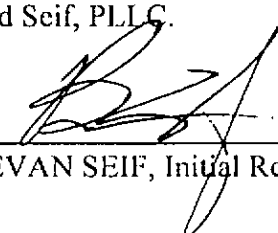
