The name of the Organization shall be **Kurt D Kaufman LLC**.



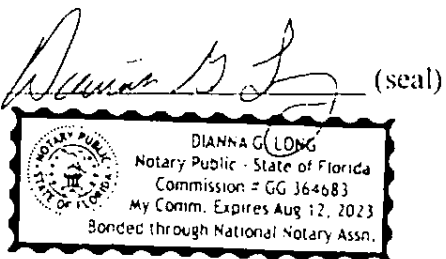
