

TO THE

ARTICLES OF INCORPORATION

OF

MEDICAL INDUSTRIES OF AMERICA, INC.

Pursuant to Provisions of the Florida Business Corporation Act

MEDICAL INDÚSTRIES OF AMERICA, INC. (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act, does hereby certify that, pursuant to the applicable section(s) of the Florida Business Corporation Act, the Shareholders approved the following resolutions of the Board of Directors on November 18, 1998:

WHEREAS, the Company's Articles of Incorporation currently authorize the Company to issue up to 50,000,000 shares of Common Stock and 10,000,000 shares of preferred stock, no par value per share ("Preferred Stock"); and

WHEREAS, the Board of Directors deems it to be in the best interests of the Company to increase the number of authorized shares of capital stock to 120,000,000 shares, consisting of 100,000,000 shares of Common Stock, \$.0025 par value per share, and 20,000,000 shares of Preferred Stock, \$1.00 par value per share.

IT IS, THEREFORE,

RESOLVED, that Article III of the Articles is deleted in its entirety and in its place the following Article III is hereby adopted and incorporated into the Articles:

The total number of shares of capital stock of all classes which the Corporation shall have authority to issue is 120,000,000 shares, consisting of 100,000,000 shares of Common Stock \$.0025 par value per share and 20,000,000 shares of Preferred Stock, \$1.00 per share.
