**Pursuant to Provisions of the
Florida Business Corporation Act**

CYBER-CARE, INC. (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act, does hereby certify that, pursuant to the applicable section(s) of the Florida Business Corporation Act, the Shareholders approved the following resolutions of the Board of Directors on August 26, 1999:

WHEREAS, the Company's Articles of Incorporation currently authorize the Company to issue up to 100,000,000 shares of \$.0025 par value per share common stock ("Common Stock") and 20,000,000 shares of preferred stock, \$1.00 par value per share ("Preferred Stock"); and

WHEREAS, the Board of Directors deems it to be in the best interests of the Company to increase the number of authorized shares of capital stock to 220,000,000 shares, consisting of 200,000,000 shares of Common Stock, \$.0025 par value per share, and 20,000,000 shares of Preferred Stock, \$1.00 par value per share.

IT IS, THEREFORE,

RESOLVED, that Article III of the Articles is deleted in its entirety and in its place the following Article III is hereby adopted and incorporated into the Articles:

The total number of shares of capital stock of all classes which the Corporation shall have authority to issue is 220,000,000 shares, consisting of 200,000,000 shares of Common Stock, \$.0025 par value per share, and 20,000,000 shares of Preferred Stock, \$1.00 par value per share.

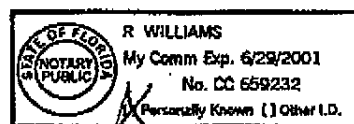
