ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

CYBER-CARE, INC.



Pursuant to Provisions of the Florida Business Corporation Act

Cyber-Care, Inc. (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act, does hereby certify that, pursuant to section 607.1003 of the Florida Business Corporation Act, the Board of Directors of the Corporation adopted the following resolution, on June 26, 2001, which resolution is in full force and in effect as of the date hereof:

WHEREAS, the Board of Directors has approved, and recommends that the Corporation's Stockholders approve, an amendment to the Corporation's Articles of Incorporation ("Articles") which would change the corporate name of the Corporation from "Cyber-Care, Inc." to "CyberCare, Inc."

The Stockholders of the Corporation, by majority vote at the annual Stockholders Meeting held on June 26, 2001 approved the foregoing resolution and authorized the amendment set forth below to the Articles. The number of votes cast at such meeting was sufficient for approval.

1. Article One of the Articles is hereby amended to reflect that the name of the Corporation is hereby changed to CyberCare, Inc.

NOW THEREFORE, Article One is hereby amended to read as follows:

The name of the Corporation is "CyberCare, Inc." (the "Corporation")
