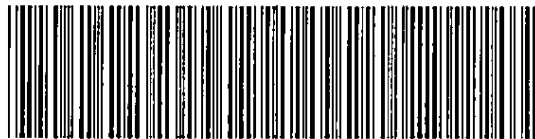

MANAGER MANAGED




