**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF  
EPE YOUNG, LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **EPE YOUNG, LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of EPE YOUNG, LLC were filed with the Florida Department of State on January 2, 2020 and assigned document number L20000000762.

SECOND: The Company's Articles of Organization are hereby amended by deleting Article III of the Articles of Organization and replacing it with the following new Article III:

**"ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company designates 4440 N.W. 168<sup>th</sup> Terrace, Miami Gardens, FL 33055 as the street address of the registered office of the Company and names, Pamela L. Thomas as the Company's registered agent at that address to accept service of process within this state."

THIRD: The Company's Articles of Organization are hereby amended by deleting Article V of the Articles of Organization and replacing it with the following new Article V:

**"ARTICLE V. MANAGEMENT**

The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The names and addresses of the persons authorized to manage and control the Company is:
