

## ARTICLES OF ORGANIZATION OF BIRO SPECULATORS, LLC

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

### ARTICLE I NAME & ADDRESS

The name of this limited liability company is **BIRO SPECULATORS**, **LLC** (the "Company"), and its principal office and mailing address is 4343 Bayside Village Drive, Unit 103, Tampa, Florida 33615.

### ARTICLE II EFFECTIVE DATE
