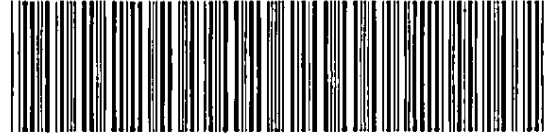

**ARTICLES OF ORGANIZATION
OF**

ARTICLE X - AMENDMENT

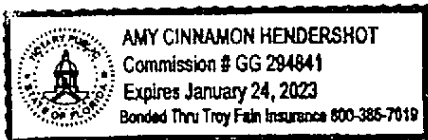
