

## ARTICLES OF ORGANIZATION GCJJ UTC, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

#### **ARTICLE I**

#### NAME

The name of the limited liability company shall be GCJJ UTC, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 5077 Fruitville Road, Suite 109-503, Sarasota, Florida 34232.

#### ARTICLE II

#### **PURPOSES AND POWERS**

#### ARTICLE III

The Company's existence shall commence on the date these Articles of Organization are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, the Company's existence shall commence upon filing by the Department of State.
