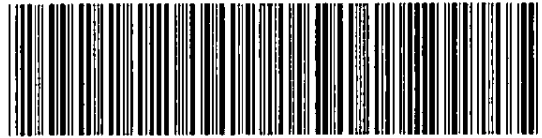

FIRST: The name of the Limited Liability Company is **4906 EDGEWATER LLC**.


