The mailing address and the street address of the principal office of this Company shall be 3556 St. Johns Avenue, Jacksonville, Florida 32205.

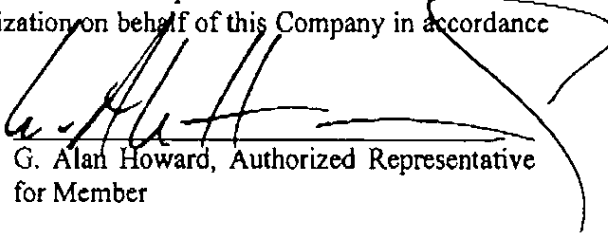

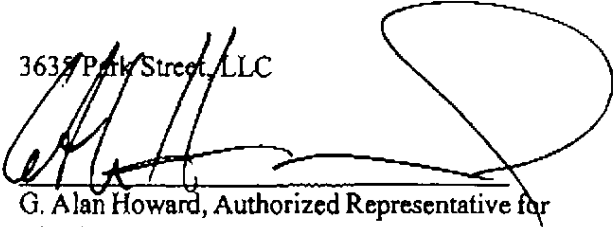

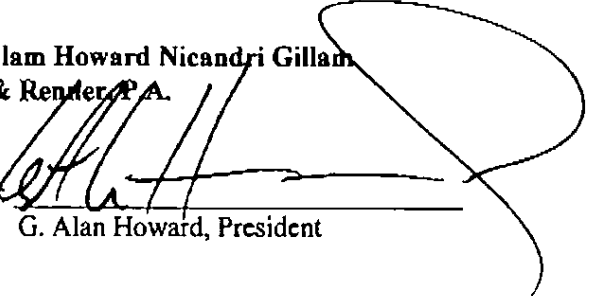
