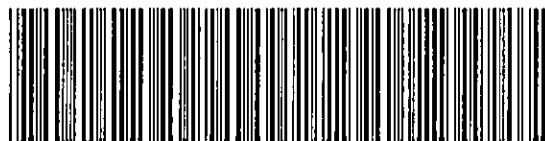

ARTICLES OF CONVERSION

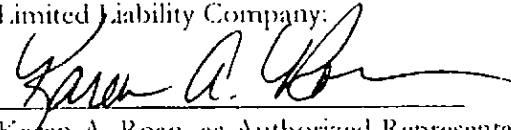

The Company's principal office and mailing address is 1641 Overlook Road, Orlando, Florida 32809.

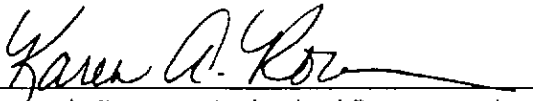

MANAGEMENT**

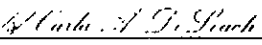
