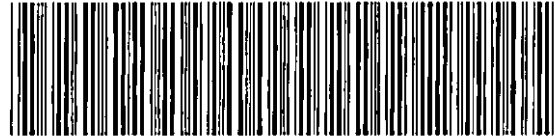

## ARTICLES OF CONVERSION

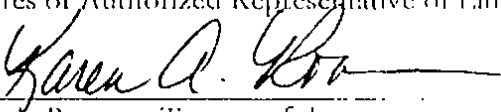

- (7) These Articles of Conversion may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute the same instrument.

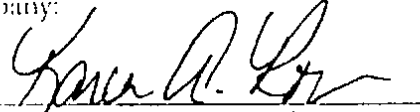

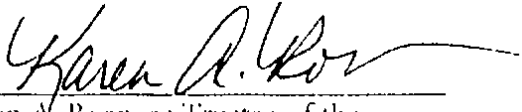

**REGISTERED AGENT AND REGISTERED OFFICE**

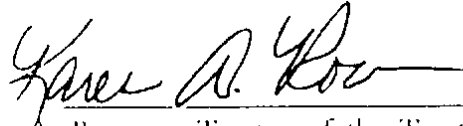
The name of the Registered Agent is DELOACH, P.L. The Registered Office is located at 1206 East Ridgewood Street, Orlando, Florida 32803.
