The undersigned, pursuant to the authority granted under Chapter 605 of the Florida Statutes, is hereby authorized to execute and file these Articles of Organization and in doing so does hereby certifies that:

ARTICLE I — Name:

The name of the Limited Liability Company organized under these Articles shall be:

WELLGROVE FARM, LLC.

ARTICLE II — Principal Office Address:

The street address of the principal office of the Limited Liability Company and the mailing address is: **1153 Stallion Drive, Loxahatchee, FL 33470.**

ARTICLE III — Effective Date and Duration:

The effective date of this Limited Liability Company shall be January 2, 2020 and the period of duration for the Limited Liability Company shall be perpetual from the date of the issuance of a Certificate of Organization by the State of Florida.

ARTICLE IV — Members and Management:

This Limited Liability Company shall have at least one member and may admit additional members in accordance with these Articles and any duly executed Operating Agreement agreed upon by the Member(s). This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The members, at a meeting of the members held not less than annually *unless otherwise specified in the Operating Agreement*, in person or by proxy, shall designate the manager(s), who *may* also be one or more of the members, and the positions that the manager(s) will hold. The initial manager(s), who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:

ARTICLE V — Admission of Additional Members:
