The undersigned, who intends to form and create a limited Liability Company, as defined in Chapter 605 of the Florida Statutes, does hereby state and certify the following:

- 1. Name. The name of the Limited Liability Company shall be BSK JAX, LLC.
- 2. <u>Duration of Company</u>. The company shall have perpetual duration.
- 3. <u>Principal Office</u>. The mailing address and street address of the principal office of the Limited Liability Company is 4827 Jones Road, Jacksonville, Florida 32219.
