**ARTICLES OF ORGANIZATION
OF**

INSIGHT COUNSELING JACKSONVILLE, PLLC

Pursuant to (i) the Florida Revised Limited Liability Company Act, Chap. 605, Florida Statutes, and (ii) the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes (together the "Acts"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

ARTICLE I - NAME

The name of the limited liability company (the "Company") shall be Insight Counseling Jacksonville, PLLC.

ARTICLE II - ADDRESS

The mailing address and the street address of the principal office of the Company shall be 2905 Corinthian Avenue, Suite 4 Jacksonville, Florida 32210.

ARTICLE III - REGISTERED AGENT

The Company elects to be governed by the provisions of the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes; and solely through duly licensed psychotherapists and clinical social workers, the Company shall provide any and all services that a psychotherapist or clinical social worker, licensed under the laws of the State of Florida, is authorized to render.

ARTICLE V - MANAGEMENT OF THE COMPANY

The Company will be a manager-managed limited liability company, to be managed in accordance with and subject to the requirements of the Acts and the Operating Agreement of the Company. The name and address of the initial manager of the Company are as follows:


