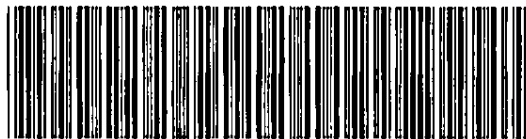

1. NAME. The name of this limited liability company is 3812 Pinewood, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

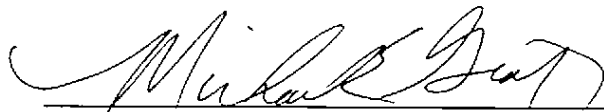

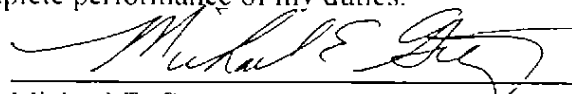
