ARTICLE 8: OPERATING AGREEMENT


The members shall unanimously adopt the initial operating agreement. The power to alter, amend or repeal the operating agreement or adopt a new operating agreement is vested in members.


ARTICLE 9: TRANSFERABILITY OF MEMBER'S INTEREST


